Here's the tea - not all contractors are equal. Anecdotal evidence suggests 30% of solar quotes in Vancouver include hidden fees. The smart move? Always ask about municipal permits. Oh, and battery storage? It's the new frontier. Tesla Powerwalls paired with solar can keep your lights on during those brutal Ontario ice storms.

But wait - there's a generational divide. Millennials are twice as likely to finance solar through green loans compared to Boomers (CIBC data). And Gen Z? They're all about community solar gardens. Different strokes for different folks, but the end goal's the same - energy independence.
